Scholarship "Sharyktau" of the Department of RMPI NAO KartU

General position

The Sharyktau scholarship of the Department of RMPI of NAO KTU is aimed at stimulating the educational, scientific and practical activities of talented and promising full-time Kazakh students at NAO KTU, studying in the educational programs "Mining" and "Construction of mining enterprises and underground structures." The scholarship is awarded on a competitive basis and is paid in addition to the generally established scholarships. The scholarship is personal, it is established for one calendar year and is paid on a monthly basis.

Conditions for participation in the competition for applicants for the "Sharyktau" scholarship of the Department of RMPI NAO Kartu: 1) the applicant is a 2 or 3 year full-time student of Karaganda Technical University on educational programs "Mining" and "Construction of mining enterprises and underground structures"; 2) the applicant must not have academic debt based on the results of the previous session; 3) the average grade points for the previous period of study (GPA) must be at least 2.6; 4) if a student is expelled from the university, the awarded scholarship is not paid starting from the date of the expulsion order.

The selection process for fellows for the program consists of three main stages:

• Stage 1 - applicants independently write an essay of the established size according to the requirements for one of the topics proposed for selection. One competitor is allowed to write only one essay on one of the selected topics. Dates - from 10 to 30 November 2021 Selection of candidates for public speaking - from 01 to 7 December 2021 • Stage 2 - public presentation (in the presence of all competitors) on the content of the essay in front of the competition committee with the submission of an electronic presentation. Dates - from 09 to 10 December 2021 • Stage 3 - determination of the scholarship holder on the basis of voting by the jury members, approved by the decision of the meeting of the department. Deadline - December 13-14, 2021 The "Sharyktau" scholarship of the RMPI Department of the NAO KTU is paid in an amount equivalent to the size of the state scholarship in the period from January 01 to December 31 of the year following the competition. A total of 1 (one) scholarship will be awarded per calendar year.

Requirements for the design of the essay:

The text of the essay, no more than 2 full pages (essays more than 2 pages - are not considered) A4 format (210x297 mm), including figures and tables, should be typed in a text editor MS Office Word in Times New Roman font (KZ Times New Roman, Times / Kaz, etc.), 14 points in size with 1.0 spacing, margins - 20 mm on all sides.

Essay presentation:

The length of the presentation should not exceed 10 slides. The minimum number of slides must be at least 7 slides.

Requirements for the content of the essay:

An essay is a prose essay of a small volume and free composition, expressing individual impressions and considerations on a specific topic or issue and obviously does not pretend to be a definitive or exhaustive interpretation of the subject.

Essay structure

The essay should have the following structure:

- 1. Introduction (introduction). The introduction reflects the reason for the competitor's interest in the chosen essay topic.
- 2. Content (main part) a reasoned presentation of the main theses. Contains definitions of the main concepts encountered. The main part is built on the basis of analytical work, including the analysis of facts.

The most important concepts included in the essay are systematized and illustrated with examples. The judgments given in the essay must be evidence-based. Proof - a set of logical methods of substantiating the truth of a position with the help of other true and related judgments. The structure of any evidence includes:

thesis - a judgment that needs to be proven;

arguments - judgments based on categories that are used to prove the truth of the thesis;

conclusion - a judgment that logically follows from the arguments given by the author.

3. Conclusion - these are the final conclusions on the topic, what the participant of the competition came to as a result of his reasoning. The conclusion summarizes the main ideas. The conclusion can be presented as a sum of judgments that can be further discussed.

When checking and evaluating the competition essays, the jury checks that each participant meets the general requirements in order to be admitted to the final in the form of a public speech, and also evaluates the content of the essay admitted to the competition in accordance with specific evaluation criteria.

Essay Topics for Scholarship Competition Entrants: 1. Mining - what will happen in 100 years? Your opinion? 2. Digitalization of mining enterprises. How do you imagine this? 3. Why will I go (not go) to work in the mining industry after graduation. Give your rationale. 4. Feasibility of innovative developments for the mining industry of Kazakhstan. What is your position?
