Rules for awarding scholarships
established by the President of the Republic of Kazakhstan

1. These Rules for the Appointment of Scholarships established by 1The President of the Republic of Kazakhstan (hereinafter referred to as the Rules) developed in accordance with paragraph 6 of the Decree of the President of the Republic of Kazakhstan dated March 5, 1993 No. 1134 "On the establishment of the scholarship of the President of the Republic Kazakhstan" and determine the procedure for the appointment of scholarships established By the President of the Republic of Kazakhstan (hereinafter referred to as the scholarship) to students higher educational institutions, regardless of the forms of ownership and departmental subordination.

2. The scholarship is aimed at:

- 1) stimulation of research and educational activities of students and magistrates;
- 2) support of the most talented and gifted students and

undergraduates;

- 3) promoting the formation of intellectual potential.

3. The distribution of the number of scholarships between higher educational institutions is carried out in proportion to the contingent of full-time students of higher educational institutions of the Republic of Kazakhstan.

4. Scholarships are not allocated to higher educational institutions with a contingent of full-time students of less than 700 people.

5. The scholarship is awarded to full-time students from the 3rd year and to undergraduates from the second year of study who study only with "excellent" (A, A-), both on the basis of a state educational order and not on a paid basis.

6. The scholarship is awarded to the following categories of students;

1) winners of national and international olympiads of creative contests, sports competitions, festivals or being: the authors of discoveries, inventions;

2) having publications in the collection; scientific papers, in republican and international scientific journals;

3) actively engaged in research work, whose successes are confirmed by diplomas, diplomas, certificates, certificates;

4) taking an active part in the social, cultural and sports life of educational organizations.

7. The appointment of the scholarship is carried out by the order of the rector of the higher educational institution on the basis of the decision of the academic Council.

8. The scholarship is awarded for one academic period.

9. The scholarship may be awarded repeatedly to the same person in accordance with the decision of the Academic Council of higher educational institutions.

10. The decision of the Academic Council of the higher educational institution on awarding scholarships for the next academic period is taken no later than two weeks before the start of the academic period and sent to the Ministry of Education and Science of the Republic of Kazakhstan with a list of students and undergraduates.

11. When awarding scholarships, applicants are selected in accordance with the criteria set out in paragraphs 5,6 of these Rules.

Under equal conditions, the following have an advantage:

orphans and children left without parental care;

disabled since childhood, disabled children.

12. If the higher educational institution has no applicants for the appointment of a scholarship meeting the criteria of paragraphs 5,6 of these Rules, higher education institutions no later than two weeks before the start during the academic period, they submit information to the authorized body in the field of education about the refusal of a certain number of scholarships.

13. Scholarships are paid monthly within the limits of funds, provided for in the republican budget for the corresponding fiscal year.
