In accordance with the "Model Rules for Admission to Educational Institutions Implementing Higher Education Programs," for the purpose of conducting high-quality creative exams in the educational programs "Architecture" and "Architecture of Environmental Spaces," conducting interviews with foreign citizens and citizens of the Republic of Kazakhstan who are enrolled in paid programs with a reduced duration of study, and conducting entrance exams for doctoral programs.

I HEREBY ORDER:

- **July 14 and 15, 2025** - reserve days of creative exams.

1.6 from June 20 to July 5, 2025, hold consultations for applicants under the educational programs "Architecture" and "Architecture of Environmental Spaces."

2. To oblige D.T. Tokanov, chairman of the examination committee, to transfer the approved form of examinations and assignments for creative entrance exams to the university admission committee by July 01, 2025.
