Information on accommodation in dormitories of NAO "Karaganda Technical University named after Abylkas Saginov"

- 1. The provision of places in dormitories to students is carried out in accordance with the Rules for the allocation of places in dormitories of organizations of higher and (or) postgraduate education dated December 30, 2022 No. 219.
- 2. In order to comply with the requirements and the objectivity of consideration of students' applications for places in dormitories, a special competition commission for the allocation of places in dormitories was established by order of the Chairman of the Board Rector of the NAO "KarTU named after Abylkas Saginov". The composition of the competition committee includes: 1) a representative of the management staff of the OVPO the deputy head of the OVPO, who oversees the issues of students' accommodation in the dormitory; 2) representatives of public organizations trade unions and other associations of citizens created on a voluntary basis; 3) representatives of student self—government bodies; 4) representatives of dean's offices deans or deputy deans in charge of student accommodation in the dormitory; 5) representatives of the structural unit of the OVPO in charge of youth policy issues.
- **3.** To provide places in the hostel, you must submit an online application via a special link http://www.kstu.kz/obshhezhitie / on the university's website in the "Quick links to student dorm" section, while attaching supporting documents for social benefits (according to the List).
- **4.** The competition committee distributes places in the dormitory on the basis of an application in accordance with the established form, taking into account the grounds and priority in the following priority order:
- 1) orphans and children left without parental care, as well as citizens of the Republic of Kazakhstan from among the youth who have lost or remained without parental care until adulthood, persons with disabilities of the first or second group, persons with disabilities since childhood, children with disabilities;
- 2) persons with disabilities of the third group, persons whose one or both parents are persons with disabilities, persons receiving state social benefits in case of loss of breadwinner, persons receiving state targeted social assistance, veterans equated with veterans of the Great Patriotic War, persons from rural youth enrolled in education according to educational programs that determine the socio-economic development of

the village, Kandasy, as well as citizens of the Republic of Kazakhstan, those who have served the prescribed term of military service during the first year of study at state-run vocational schools or vocational schools, more than fifty percent of the voting shares (shares in the authorized capital) of which belong to the state, or vocational schools in which a state educational order is placed;

- 3) students within the framework of the project "Mangilik el zhastary industriyaga!" (Serpin -2050);
- 4) students enrolled in the first year who have the "Altyn Belgi" badge, students who have a certificate of the winner or prize-winner of the Presidential, international and republican Olympiads and (or) competitions, as well as applicants who graduated from the organization with honors with a supporting document of education (certificate, certificate, diploma);
- 5) students who have been accepted for the first year of study in accordance with the state educational order, who have a high score based on the results of the Unified National Testing or Comprehensive Testing, entrance exams in subjects or in the form of testing conducted by an educational organization. If scores are equal based on the results of the Unified National Testing or Comprehensive Testing, entrance exams in subjects or in the form of testing conducted by an educational organization, the financial situation of the student is taken into account in accordance with the Rules for the formation, direction of expenditure and accounting of funds allocated for the provision of financial and material assistance to students and pupils of state educational organizations from families eligible for receiving state targeted social assistance, as well as from families, those who do not receive state targeted social assistance, in which the average per capita income is below the subsistence level, and orphans, children left without parental care, living in families, children from families requiring emergency assistance as a result of emergency situations, and other categories of students and pupils approved by the decree of the Government of the Republic of Kazakhstan dated January 25, 2008 Year No. 64;
- 6) students from among the senior students who have high results in academic, scientific and social work;
- 7) other students of OVPO. Foreigners from among the students are provided with places in the dormitory in accordance with international and intergovernmental agreements.

- **5.** The decision of the Commission is to issue a referral for accommodation in a dormitory or to refuse to provide a place. The direction for settling into the hostel is generated automatically and sent to the student's email address.
- **6.** Upon completion of the check-in, a personal file of each student is formed (in the database of the administrator and the dean of the faculty), in which all violations are subsequently recorded in accordance with the Rules of Residence in dormitories. According to their results, the student can be evicted and is refused to move in the next academic year.

Attention!

The application for dorm places for the 2023-2024 academic year will be available from August 20, 2025 (for consideration by the competition Committee for the allocation of dorm places), with the exception of senior students (after August 29, 2025).

The student is obligated after allocating a place in the dormitory

- 1. Upon arrival in Karaganda at the railway station or bus station, take bus No. 1 to the university (stop right at the station building) to the Akimat stop.
- 2. Go to the dormitory indicated in the direction and leave your belongings in the luggage room. The addresses of the dormitories are N. Nazarbayev Avenue, 56/2; N. Nazarbayev Avenue, 56/6; N. Nazarbayev Avenue, 60
- 3. Go to the Health Center of the NAO "Karta named after Abylkas Saginov" (1st floor in the residential complex "Armandastar Ordasy") medical examination for pediculosis and scabies with a certificate of completion;
- 4. Pay in the cash departments of second-tier banks the cost of accommodation for semesters: autumn September 2025 January 2026 upon check-in; spring for February June 2026 by 1.02.2026). Submit copies of the payment receipt to the administrator and the dean of the faculty. It is mandatory to indicate in the receipts "Full name for accommodation in the hostel".;
- 5. In the dormitory, fill out and sign two copies of the Residential Lease Agreement (one for the administrator, the second for the student); sign the Certificate of acceptance and transfer of the residential premises with

the appropriate set of furniture, bedding; the questionnaire of the resident in the dormitory;

- **6.** Provide the administrator of the hostel with the following list of documents:
- photo in the size of 3*4 (3 pcs.);
- copies of the identity document (2 pcs.);
- certificate for pediculosis, scabies (Health center of the NAO "Abylkas Saginov Card", 1st floor, Armandastar Ordasy residential complex) upon check-in;
- document file (2 pcs.binder), binder;
- a receipt for payment FOR the HOSTEL (in accordance with the agreement, the semester fee is: 50% upon check-in (for September January), 50% by 1.02.2026. (February June); originals (for verification) and copies of documents confirming membership in the social category. In the absence of supporting documents or if false information is provided, the check-in will be refused.
- **7.** Within 2 weeks, go through the temporary registration procedure (through the passport office of the NAO "Abylkas Saginov Card" Studentter uyi dormitory, 1st floor, 114 office)
- **8.** Inform the curator of the academic group of the room number of the corresponding dormitory.

In the absence of payment, supporting documents, or false information, the student will be denied entry!!!
